Conduct of Joint Entrance Exam JEE (Main) 2018 (Offline) scheduled to be held on 8th April, 2018 (Sunday)

It is brought to the notice of all concerned that the Executive Director (JAB), Central Board of Secondary Education, Noida, UP vide letter dated 05.09.2017 has informed that the Ministry of Human Resource, Development, Govt. of India has decided to conduct the Joint Entrance Exam (JEE Main)-2018 for admission in IITs, NITs, IIITs and other centrally funded Technical Institutions/ State Level Institutions, who have opted to take part in the Examination in the Country through JEE (Main). The 6th Joint Entrance Examination JEE (Main), will be conducted on **8th April, 2018 (Sunday)**. Further, the dates for conduct of JEE (Main) 2018 (Online) will be intimated in due course of time.
